**Admission Notice Third Round**

**(Guidelines for Provisional Admission for M. Sc. I, 2024-2025)**

**1. Third counseling cum Provisional admission round will be held on 5<sup>th</sup> July 2024 at 11.30 am in room No. 45, First floor, Department of Chemistry, The Institute of Science, 15-Madame Cama Road, Mumbai-32.**

Details of vacant seats for third round of admission is given below

**1) Physical Chemistry = 14**

**2) Inorganic Chemistry =11**

Provisional Admission will be based exclusively on merit basis criterion -Viz

- a) Percentage marks in Semester V and Semester VI
- b) For a candidate having an equal percentage of marks, a higher CGPA shall be preferred for admission
- c) For a candidate having an equal percentage of marks and CGPA, the candidate with a higher percentage of marks in chemistry subject in Sem V and Sem VI will be preferred for admission.

**2. All Candidates should remain present for the third round of admission.**

3. All the reservations shall apply to candidates belonging to Maharashtra State only subject to the fulfillment of the eligibility criteria specified by respective authorities from time to time.

4. At the time of admission candidate should remain present personally with the required original documents. Those personally present candidates for the third round will only be considered for the subsequent Rounds.

5. The candidates belonging to SC, VJ/DT (NT (A), NT (B), NT(C), NT (D), OBC, SBC and EWS categories shall produce "Caste Validity Certificate" and ST category shall submit "Tribe Validity Certificate". All reserve category candidates **excluding SC & ST** shall produce **Non Creamy Layer(NCL)** certificate valid up to **31<sup>st</sup> March 2025**. If such candidates fail to produce the original certificate or receipt of Caste/Tribe validity certificate, Non Creamy Layer certificate, and EWS certificate issued by the competent authority at the time of verification, then such candidates will be treated as **GENERAL** category candidates for Admissions.

6. EWS and SEBC candidates shall produce the Eligibility Certificate issued by the competent authority.

7. Documents to be produced at the time of admission-

- i. Printed copy of application form along with Xerox copies of all documents.
- ii. F.Y., S.Y.T.Y.B.Sc. Statement of marks or SEM I to VI B.Sc Mark statement (Original Documents).
- iii. Std. XII mark sheet
- iv. Caste certificate, Caste validity certificate (Excluding SC) and Non Creamy Layer Certificate (NCL) wherever applicable (VJ/DT(NT-A), NT-B, NT-C, NT-D, OBC, SBC, and EWS, Categories)
- v. Gap certificate if any gap in academic carrier

8. Seat will be allotted after verification of the original documents and ensuring that the Candidate meets all the eligibility norms. The admission in charge of the institute will issue the **Offer Letter** to the provisionally admitted candidate.

9. Candidates who have secured the admission pay their fees online by **7<sup>th</sup> July, 2024 up to 5.00 p.m.** Failing to pay fees in the prescribed time will forfeit the admission claim for subsequent rounds.

10. A Candidate who has been allotted a seat shall submit the “Provisional Seat Allotment Letter” along with a copy of the fee receipt.

11. If any seats remain vacant in 3<sup>rd</sup> round, **SPOT ROUND** of admission will be held, for the spot round prior notice will be displayed on website accordingly and also communicated to the students.
